#### **Turbulent Demand Drives Record 2021 Rebound**

Welcome to the 2022 edition of MDM's annual ranking of the top 150+ North American industrial and construction product distributors across 17 product sectors. This is the 13th year MDM has profiled the size and shape of these markets. Visit www.mdm.com/top\_distributors to view directory pages for each of the more than 150 distribution companies in these lists, including key contacts, number of locations, employees and more.

Distributors fought their way through 2020, with many absorbing considerable revenue and profit losses amid a nosedive in product demand across numerous industries. And while the economic impacts of the COVID-19 pandemic largely subsided throughout 2021, disruptions only multiplied across supply chain, talent and rising inflation during the year.

But the continued volatility had a positive side. Distributors across all sectors posted record revenues as markets bounced back; the entire U.S. wholesale distribution industry posted revenues of \$7.1 trillion in 2021, an increase of nearly 23% in actual revenues over 2020 revenues (and about 8% in real revenues after adjusting for inflation impacts).

This report ranks more than 150 of the largest distributors by revenue size, operating across 17 distribution product sectors serving industrial, building materials, construction, electrical and commercial markets. MDM Analytics estimates the total North American market size for the product categories sold by the companies listed here at approximately \$650 billion (U.S. market \$550 billion). Please see the Methodology section at the end of this introduction for more information on how the lists are compiled.

This directory confirms just how fragmented the wholesale distribution industry remains today across each of the 17 sectors profiled here. With the exception of the Electronics sector, there is very low concentration of market share across each of these sectors (MDM Premium members: watch for MDM's follow-up market share analysis report soon).

That's why it's important to note that ranking distributors solely on revenue is far from an apples-to-apples process. Every company on this list competes tangentially at some level, even within specific product sectors. And the very nature of broadline distribution – with product portfolios representing millions of maintenance, repair, operating, production and consumable products – means that every competitor has an overlapping product assortment.

#### **Amazon Business Keeps Shifting the Landscape**

The explosive growth of Amazon Business, marketplaces and eCommerce as alternate channels fuels even further

the product portfolio expansion and fight for market share outside traditional customer segments served.

We chart Amazon Business as our second largest distributor for Industrial and MRO, though the B2B marketplace remains notoriously silent about breaking out revenues aside from an occasional overall figure, with the most recent stating \$25 billion in 2020 revenue. MDM's calculation puts Amazon Business' 2021 share of the industrial/MRO categories at more than \$7.5 billion, allowing it to edge out No. 3 Motion Industries in both verticals, though still trailing Grainger's \$13 billion.

Of any estimates in this report, we are the first to admit this is the most opaque; Amazon is likely just fine with that. Their product portfolio goes far beyond the aggregation of all the sectors profiled here. Our rationale in their ranking for these sectors is based on an admittedly imperfect estimate of their percentage of revenues in the category, their overall scale and dozens of conversations with suppliers and distributors on specific product-category strength.

Finally, we include them as the elephant in the warehouse. As with other traditional distributors who would prefer not to be visible, our team feels it would be inaccurate to not include Amazon Business – as difficult as it may be to accurately rank them – in a meaingful analysis of the current competitive landscape of these market sectors.

#### Robust M&A Shakes Up Rankings

As always, mergers and acquisitions played a major role in shaping this year's MDM Top Distributor rankings, but that was especially so for this year's list after the robust activity seen during 2021 and the first half of 2022. And even though our rankings are based on 2021 revenues, deals announced up until our publishing deadline were factored in. Narrowly making the cut was JanSan and foodservice distributor BradyIFS' purchase of related firm Hill & Markes, announced just days before our production cutoff. That deal removed Hill & Markes from our list while vaulting BradyIFS onto our top 10 JanSan distributors for the first time.

That acquisition is a good example of a notable difference in this year's list and those of past years. Starting this year, MDM will no longer list a distributor and any of its subsidiaries within the same category, as that would be double-dipping for the parent company. This is why you won't see companies like Mayer Electric (owned by Rexel) or United Distribution Group (owned by SunSource) on our rankings, as only their parent company will appear within their respective categories.

Motion's \$1.3 billion bolt-on of Kaman Distribution Group that was completed at the start of 2022; The Home Depot's \$8 billion purchase of HD Supply — completed at the end of 2020; Vallen's spinoff from Sonepar USA; and Builders FirstSource's \$2.5 billion purchase of BMC Stock Holdings, among others.

After starting slow in 2021's first quarter, M&A activity grew stronger throughout 2021. As MDM reported, private equity firms, which accounted for about half of all distribution M&A activity in 2021, were highly motivated to deploy pent-up capital heading into 2021 after activity was dormant for the last nine months of 2020. On the flip side, more owners, fatigued with the challenges of 2020, made the decision to pull the rip cord and sell.

#### New for 2022: Industry-Specific Revenue

A key difference between this year's Top Distributors and those in years past is that we rank companies by their industry-specific revenues, rather than total revenue. While ranked based on their revenue in each category, the "2021 revenue" figure you'll see for all companies is their total revenue.

For example, Ferguson is the largest U.S. distributor of plumbing supplies, PVF, waterworks and fire and fabrication products, with total 2021 revenue of \$22.8 billion. But it is also a major distributor of HVAC equipment and industrial products, with approximately \$7 billion in combined revenues for those product categories across industrial and construction verticals. Because of that, we rank Ferguson based on that \$7-billion figure within our Top Industrial Distributors. As another example, you'll see that Motion and Winsupply round out our Electrical, Data & Security rankings despite total portfolio revenue that dwarfs many of the companies above them in that sector.

#### Methodology

Data for MDM's Top Distributors are based on 2021 revenues, either reported publicly, through surveys MDM conducts annually or estimated by MDM's researchers. In most cases, we used fiscal 2021 revenues, but in some cases, MDM uses calendar-year revenues for a more

accurate comparison. To normalize the way we formulate the rankings, we include total company revenues, rather than break out individual sector revenues.

For companies that don't share revenue data publicly, MDM triangulates relative rank position for each list based on a combination of factors. These factors include: number of branch locations and/or employees, confidential reporting by specific companies, and guidance through a wide range of industry veterans that include suppliers, former employees and competitors to provide as accurate as possible in developing this type of industry competitive profile. Though we get requests from companies that would prefer not to be listed, we feel it would damage the accuracy and value of this annual benchmarking tool.

Four of MDM's Top Distributor List categories are unranked and instead listed in alphabetical order: Safety, JanSan, Gases & Welding, and Specialty Adhesives. There are two main reasons why we don't rank an industry product sector. For the safety and JanSan sectors, the more advanced commoditization level makes it difficult to accurately apportion revenues across the combination of the sector specialists and the much larger general-line competitors that more often than not do not segment out their product category revenue results. The Gases & Welding and Specialty Adhesives sectors also share this characteristic to a degree, and also represent smaller specialty niches where private company revenues are difficult to accurately estimate.

#### **Questions & Comments Welcome**

As noted above, this is a complex research effort, and we thank the many companies, consultants and industry veterans who generously share their insights on the complex competitive landscape that defines these market channels. We feel this research provides value to the industry beyond simpler rankings that don't reflect the true diversity at play here. As always, we welcome your corrections, comments and suggestions to make this annual report more valuable to you and the industry at large.

While there is considerable overlap between MDM's verticals for industrial and MRO industrial, we consider there to be enough nuance specific to MRO to warrant breaking out its own Top Distributors list. While every MRO product may be considered an industrial product, the opposite isn't always true. For MDM, MRO products are those needed to keep a company's facilities and production processes running smoothly, whereas industrial products encompass MRO in addition to products involved in the manufacturing process and/or components used in the final product.
